Treasurer's Report – Chelsea Rebeck

- Currently \$14,000.00 available in the budget.

- \$7000.00 reserved in the track fund.
- \$5500.00 available in this year's budget.
- **Media Center Renovations**
 - Motion by Chris Rashid to allocate \$3000.00 for media center renovations, including the purchase of tables and chairs. Seconded by Laurie Peggs.

The motion passed unanimously.

5th Grade class is donating a 16-ft. bulletin board to the Media Center as a class gift.

- **End-Of-Year Gifts**
 - Need to transfer \$120.00 for end-of-year gifts. Motion by Trisha Rouse. Seconded by Aimee Brown.

The motion passed unanimously.

- **School Beautification**
 - Need to allocate \$600.00 for the purchase of a tree in memory of Mr. Waltz.
 - Motion by Trisha Rouse to move \$600 to School Beautification. Seconded by Chris Rashid.

The motion passed unanimously.

- **Storage Shed for PTA**
 - Motion by Trisha shed to allocate \$1500.00 towards the purchase of a shed and a cement slab. Seconded by Aimee Brown.

The motion passed unanimously.

Family Events – Aimee Brown

- **Spring Fair**
 - 50/50 raffle raised \$135.00
 - The raffle raised \$1577.00. PTA spent \$425.00 on the raffle. The raffle expenses increased this year.
 - Ticket sales - \$4335.00. There was a large increase in wristband sales this year.

 - Mr. Stearns has elected to retire. Laura laquinto is moving to Walnut Creek Middle School.
 - The District issued layoff notices. (3) Oakley Park teachers are affected.
 - The District is still waiting for budget information from the State of Michigan. A \$7.2 million funding gap is anticipated for next school year.
